AGREEMENT BETWEEN THE UNIVERSIDADE DO VALE DO ITAJAÍ – UNIVALI AND WIDENER UNIVERSITY – DELAWARE LAW SCHOOL FOR IMPLEMENTATION OF THE INTERNATIONAL MOBILITY PROGRAM OF VISITING TEACHERS THROUGH RECIPROCITY SCHOLARSHIP

Considering that the Universidade do Vale do Itajaí (hereinafter “UNIVALI”) and Widener University - Delaware Law School (hereinafter “Delaware Law School”) develop bilateral cooperation activities and wish to intensify this partnership in their respective Master's and Doctorate Courses, both UNIVALI and Delaware Law School agree, through this Agreement, to the following clauses:

ARTICLE 1: Purpose

The objective of this agreement is the maintenance of the the International Visiting Professor Mobility Program, through the granting of reciprocal scholarships, in order to promote cooperation between UNIVALI and Delaware Law School in the exchange of professors and administrators between the two institutions. for didactic purposes, including, among other actions, holding seminars and lectures, in addition to orientation, programmatic and curricular activities for students in their Master's and Doctorate Courses, especially in relation to double degree programs.

ARTICLE 2: Visiting Professors

By virtue of this Agreement, considering the Professors' CV, as well as their experience with internationalization, they are now considered Visiting Professors for the purposes of this agreement:

It is the responsibility of the Coordinator of the Dual Degree Program with Delaware Law School (Prof. Marcelo Buzaglo Dantas) and the Coordinator of the Dual Degree Program with UNIVALI (Assistant Dean Eileen Grena) to manage this Agreement so that the terms are completely complied with by both institutions.

ARTICLE 3 – Legal Basis

This Agreement is based on the Memorandum of Understanding signed between the two institutions on June 14, 2022 and other applicable legal standards.

ARTICLE 4 – Permanence of the Visiting Professor at the partner university

The Visiting Professor's stay at the partner university, for the purposes stipulated in this agreement, will be agreed between the parties, respecting internal rules and without prejudice to the academic obligations of the participants in this program at their respective Universities, which must be fully guaranteed.

ARTICLE 5 – Financial Responsibilities

Each institution will be responsible for the remuneration of its own Professors when they are Visiting Professors, and must therefore assume the costs of replacing Visiting Professors during the period in which they are working at the other University.

The contracting of international health insurance and insurance against accidents and third parties will be subject to adjustment between the Professors themselves and their respective Institutions.

ARTICLE 6 – General Conditions

Planning the visit, especially in relation to benefits, such as accommodation and food reservations, will be the subject of discussions between the Visiting Professor and the partner university, as the budget and resources are available for this purpose in accordance with internal regulations of each institution.

ARTICLE 7 – Duration and Modification of the Agreement

This instrument will be signed and will commit both institutions for a period of 48 (forty-eight) months from the date of the last signature.

ARTICLE 8 – Termination and Review of the Agreement

This Agreement may be terminated or terminated at any time by written notice given 6 (six) months in advance by the universities. The two institutions may initiate a review prior to the expiration of this Agreement to determine whether the program should be modified. If there is no response from the parties, the Agreement will be automatically renewed for the same period.

ARTICLE 9 – Competent Forum

Any dispute related to the interpretation of this Agreement will be resolved amicably between the institutions. A specific jurisdiction will be designated to resolve any dispute arising from the requesting party's Agreement.
